

TO WHOM IT MAY CONCERN**APPOINTMENT AS TAX ADVISOR - TAXCO**

I, _____ (the Taxpayer) hereby appoint the accounting firm, Taxco, to be my representative with full power and authority to act on my behalf in respect to my tax and compliance related business affairs.

TO SIGN AND SUBMIT

This appointment includes the authority to sign and submit for and on my behalf and for any Company, CC, Partnership or Trust of which I am a director, member, partner or trustee, any returns or financial statements and other documents required by the authorities from time to time. This will include, but not be limited to, VAT101, IRP101, IT12, IT14 and all other SARS, UIF, Statistics and WCA returns.

ENQUIRIES, PAYMENTS, REGISTRATIONS AND APPLICATIONS

This appointment further includes the right to enquire into any matter regarding my tax affairs or compliance of that of a Company, CC, Partnership or Trust to whom I may be associated with regarding taxation, any other levies and/or contributions received or paid to insurance, banks and/or other companies. This appointment further includes the right to sort out queries on any related matter, the handling of payments and the collection of refunds on my behalf. To make, assist and advise on registrations, applications and prospective applications for any Tax registration, amnesty, exemption, grant or deduction as required for whoever, from time to time.

SARS E-FILING

This appointment further includes the right for Taxco to register myself and or any Company, CC, Trust or any other entity with whom I am associated on SARS E-filing as a separate User on the Taxco SARS E-filing profile and to electronically submit and pay any due and payable returns through SARS E-filing on my created User account. It is my responsibility to ensure that amounts are completed correctly by Taxco on the submitted forms and sufficient funds are available for the payment of such returns as and when due. The Taxpayer is the declarant, notwithstanding the fact that Taxco may complete the return based on information supplied by the Taxpayer or who actually completes the return, and at all times declares that the returns submitted were checked by the Taxpayer and once submitted, are complete and correct.

TAXPAYER RESPONSIBILITY

I understand that I am the Taxpayer and that it is my responsibility to ensure that my tax affairs are up to date and kept in such a manner that is required by any law and all information supplied is true and correct. I am fully aware that Taxco can only act on information and representations provided by myself and I accept full responsibility for any taxation, levies, penalties and interest that may become due from time to time and exempt Taxco, it's trustees and employees, without prejudice, from all such liabilities in this regard.

SPECIFIC DUTIES

I instruct Taxco, as and when, on the basis of information supplied to them, to submit on an monthly or bi-monthly or other period as SARS or other governing body may require, my Income Tax, Provisional Tax, Vat, PAYE and other tax related and business or statutory returns.
